

## Exhibit C - Siskiyou County R/C'ers Operating Rules

1. All R/C models must be flown in accordance with the following FAA documents:
  - a. FAA Modernization and Reform Act of 2012, SPECIAL RULE FOR MODEL AIRCRAFT
  - b. FAA Advisory Circular, AC No. 91- 57A
2. Under the SPECIAL RULE FOR MODEL AIRCRAFT all R/C pilots must:
  - a. Fly for hobby or recreation ONLY (No flying for business or professional purposes)
  - b. Register their model aircraft with the FAA
  - c. Fly within visual line-of-sight
  - d. Follow community-based safety guidelines and fly within the programming of a nationwide community-based organization
  - e. Fly an aircraft under 55 lbs. unless certified by a community-based organization
  - f. Never fly near other aircraft
  - g. Notify the airport and air traffic control tower prior to flying within 5 miles of an airport
  - h. Never fly near emergency response efforts
3. All R/C models must also be flown in accordance with FAA Advisory Circular AC No. 91-57A, which provides guidance to persons operating Unmanned Aircraft for hobby or recreation purposes and describes means by which model aircraft may be operated safely in the National Airspace System.
4. In reference to 2.d and 2.e. above, the nationwide community-based organization shall be the Academy of Model Aeronautics ([www.modelaircraft.org](http://www.modelaircraft.org)).
5. All Siskiyou County R/C'ers members must be current members of the Academy of Model Aeronautics.
6. All persons operating R/C models at the Airport must be current members or guests of the Siskiyou County R/C'ers.
7. All guest R/C pilots who intend to fly must be current members of the Academy of Model Aeronautics, must fly in accordance with all applicable FAA Rules for Model Aircraft, be shown the airport's flying boundaries (Exhibit A) and be given a copy of the club's safety rules and must be escorted by a current member.
8. All R/C pilots must fly their models in a careful, responsible and safe manner.
9. R/C pilots who are preparing to fly an R/C model for the first time (maiden flight) must have their model inspected for safety by a club officer or experienced pilot (someone other than themselves).
10. Siskiyou County R/C'ers rules require that no R/C model shall weigh more than 35 lbs.
11. No R/C model shall be powered by jet engine.
12. All models must be operated using only radio control frequencies currently allowed by the Federal Communication Commission.
  - a. All R/C models must be flown using state-of-the-art 2.4 GHz spread-spectrum technology.
  - b. All R/C pilots must conduct a radio range check before each R/C model is flown for the first time that day.
  - c. All R/C pilots must confirm that the transmitter and receiver are linked per the range check procedure specified by the radio's manufacturer.

## Exhibit C - Siskiyou County R/C'ers Operating Rules

13. All R/C models must be identified with the owner's name, address, AMA number and FAA registration number on or in the model.
14. All R/C models must be flown no more than 300 feet above the airport surface and operated only within the operating areas as shown on Exhibit A.
15. All R/C models must be flown only in the areas as shown on Exhibit A. Parking and ground activities must be limited to the Ground Operations Area as shown on Exhibit A.
16. All model flying must give right-of-way and avoid flying in the proximity of full-scale aircraft at all times.
17. An observer must be utilized to supervise flying to ensure that R/C aircraft are never in the proximity of full-scale aircraft. For this reason, R/C pilots are not permitted to fly alone.
18. UNICOM frequency of 123.000 MHz must be monitored at all times in order to further alert R/C pilots of the presence of full-scale aircraft.
19. All R/C pilots shall ensure that the flying area is clear of all non-club members and spectators before initiating flight activities.
20. All model flying must be suspended whenever a temporary flight restriction (TFR) is in effect (e.g., when firefighting aircraft are present at the airport).
21. Siskiyou County R/C'ers flight operations shall be limited to one hour after dawn to one hour prior to dusk.
22. No alcoholic beverages will be allowed at the airport nor will any alcoholic beverages be consumed prior to, or during participation in any model operations.
23. All members must sign the Siskiyou County Airport Gate Access Agreement prior to operating on the Premises.
